Tawnsheeshi chi-outistikouyin weechihiwaywina pi lee krijee?

Kiya pi toon nasasyee keema ki-weechayamaw en partineuz pikou chi-itoutamayk tee la tax araw li mwawd Awvree 30 itahtow aen nawn chi-outistikouyin weechihiwaywina pi lee krijee chikée kushkihtamawshoowin, kiyawm keeshpin lkouhk larzhawn ka-oushihayt aykwawna namoo la tax-outinikawtayw keema namoo kaykwuy ki-kashkishchikawn. Keeshpin ki-weekin didawn Quebec, pikou meena chi-itoutamaen en provayns kaw-wawpaschikawtayk li tax. Tawmykoohk kaw-kee-outistikoun itahtow aen nawn?

CCB – ishko **\$7,997** poor itahtow aen zawnfawn awntser 6 awn ayow pi ishko **\$6,748** poor itahtow aen zawnfawn 6 awn ayow ishko 17. Natouta poor kahkiyuw lee zawnfawn kaw-keniwayimichik keeshpin namoo cheskwa kee-natoutaen awnshay pi namoo awiyek outistikow aykwawnima. Natouta en zawnfawn keniwayimoowin maenshtinikaywina keeshpin ki-tipahamiwow awiyek chi-kenawayimawt tee zawnfawn.

GST/HST li krijee – ishko **\$533** poor payyakoow kushkihtamawshoow pi ishko **\$1,066** poor la koupil kushkihtamawshoowak avek deu lee zawnfawn.

Kenadaw otatoushkaywak weechihiwaywin – ishko **\$1,590** poor payyakoow kushkihtamawshoow pi ishko **\$2,739** poor kushkihtamawshoowak en famee. Ooma tipahikaywin li krijee ashaynanam la tax kaw-mashinahikaywin neekawn pi kaw-ishkopayihk li krijee ki-tipahamakawin.
