

## 2019 Ontario energy and property tax credit (OEPTC) - Calculation sheet for single seniors who have the sole care of at least one child

Use this calculation if you were **64 years of age or older** and single on December 31, 2018, and you have the sole care of at least one child who is under the age of 18 on the first day of the payment month.

You may have to use a different calculation sheet for a particular month if the care of any of your children changes.

If you will receive or have received a 2019 Ontario senior homeowners' property tax grant (OSHPTG), complete lines 23 to 29. Otherwise enter "0" at line 29 and continue on line 30 below.

If your annual OEPTC amount plus, if applicable, your annual Ontario sales tax credit and Northern Ontario energy credit is:

- \$2.00 or less, no payment will be issued.
- from \$2.01 to \$10.00, you will receive one payment of \$10.00.
- \$360.00 or less, you will receive it in one payment instead of monthly.

The first monthly 2019 Ontario trillium benefit payment, which includes any OEPTC entitlement, will be issued on July 10, 2019.

However, if you made a choice on your 2018 return to wait to receive your 2019 OTB entitlement, it will be issued on June 10, 2020.
