As a result, the totals for employee and average per employee are not displayed. The total number of applications does not represent the number of unique employers.
4. All counts are rounded to the nearest ten. Approved CEWS amounts are rounded to the nearest thousand. Average amounts are rounded to the nearest dollar. Percentages are rounded to the nearest whole percentage.
