<sup>1</sup> Treatment plan details indicating all relevant completed and pending treatment needs, or, based on the provider's scope of practice, confirmation that potential basic treatment needs are being referred and/or will be addressed. This does not need to be submitted as a stand-alone document labelled 'treatment plan' so long as the information is included in the documentation submitted.

<sup>2</sup> Planned/proposed treatment to be completed during sedation session.

<sup>3</sup> Dated panoramic radiograph will be considered when it is not possible to obtain intraoral radiographs, as indicated in a rationale.

<sup>4</sup> Dated periapical radiographs only

<sup>5</sup> **One** of the following is required:

- dated periapical radiographs of abutment teeth and dated bitewing radiographs (within last 12 months); or
- when it is not possible to obtain periapical or bitewing radiographs, the most recent dated panoramic radiograph; or
- if radiographs are not available, **one** of the following:
  - dated photos of the upper and lower arches (2) (upper and lower separate); or
  - dated photos of stone models (2) (upper and lower separate); or
  - dated stone models (upper and lower).

<sup>6</sup> If a complete periodontal chart cannot be provided, a rationale is required to explain why the chart is incomplete and to provide any relevant information not captured in the chart.

<sup>7</sup> If a complete periodontal chart is not available, a dated Periodontal Screening and Recording (PSR) for each sextant along with periodontal measurements of 6 sites for each tooth requested from within the last 12 months will be considered.

- With a PSR score of 4 in any sextant or a score of 3 in two or more sextants, a complete periodontal chart must be submitted.
- With a PSR score of 3 in the sextant in the tooth/teeth being requested, charting of the sextant must be submitted.
