Crude oil and natural gas: Supply and disposition

July 2008 (preliminary)

Domestic production of crude oil and equivalent hydrocarbons totalled 13.9 million cubic metres in July, up 2.5% compared with July 2007.

Deliveries of crude oil and equivalent hydrocarbons to the export market decreased by 2.5% compared with the same month in 2007. In July 2008, 63% of Canada's total production went to the export market.

Domestic sales of natural gas fell 1.2% from the same month in 2007. This decrease was the result of lower sales to all three sectors (residential, commercial and industrial).

Marketable natural gas production declined 0.9% in July 2008 compared with the same month a year earlier.

However, marketable natural gas production increased 12.8% from June 2008.

Natural gas exports in July 2008 made up 62% of marketable natural gas production.

Canadian Vehicle Survey

January to March 2008

Canadians drove their vehicles less during the first quarter of 2008 compared with the first quarter of 2007. Nationally, kilometres declined 3.1%. Light vehicles (weighing less than 4.5 metric tonnes) were driven 3.4% less, while the use of heavy vehicles (weighing 4.5 tonnes or more) was basically unchanged. Severe weather in much of the country during the quarter, as well as steadily increasing fuel prices, likely played a role in reducing vehicle use.

While vehicle-kilometres were lower, there were more cars and trucks registered compared with a year earlier. Vehicle registrations increased by 2.7% from the first quarter of 2007. Registrations for light vehicles rose by 2.6% while registrations for heavy vehicles increased by 5.4%.

Light vehicles in Canada travelled an average of 3,407 kilometres during the first quarter, the lowest average recorded since the initiation of the Canadian Vehicle Survey in the fourth quarter of 1999. Among the provinces, Albertans drove the most on average, while drivers in Newfoundland and Labrador drove their vehicles the least.

The use of large passenger styles (vans, sport utility vehicles and pickup trucks) dropped by 14.8% compared with the first quarter of 2007. Smaller styles (cars and station wagons), on the other hand, were driven 8.1% more.

Fuel efficiency for light vehicles using gasoline was 11.5 L/100km, which was virtually unchanged from the first quarter of 2007.
