Releases

Building permits

December 2008

Municipalities issued \$4.6 billion in building permits in December, down 3.9% from November. This third consecutive monthly decline was the result of decreases in both the residential and non-residential sectors.

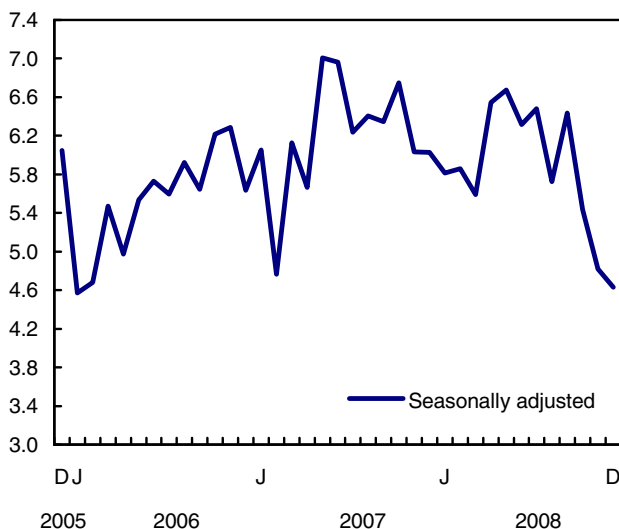
The value of residential permits declined by 3.2% to \$2.6 billion, the ninth monthly decrease in 2008. Increases in multi-family permits in Ontario were not enough to offset the declines in single-family permits in Ontario, Alberta and British Columbia.

The value of permits in the non-residential sector declined 4.9% to \$2.0 billion, the third consecutive monthly decrease. This decrease came mainly from institutional permits in Alberta and commercial permits in British Columbia.

Construction intentions were down in five provinces and all three territories.

Residential sector: Six consecutive monthly declines for single-family permits

The value of single-family permits fell 10.8% to \$1.6 billion in December, their sixth monthly decline in a row. The drop in December occurred mainly as

Note to readers

Unless otherwise stated, this release presents seasonally adjusted data, which eases comparisons by removing the effects of seasonal variations.

The Building Permits Survey covers 2,400 municipalities representing 95% of the population. It provides an early indication of building activity. The communities representing the other 5% of the population are very small, and their levels of building activity have little impact on the total.

The value of planned construction activities shown in this release excludes engineering projects (e.g., waterworks, sewers or culverts) and land.

For the purpose of this release, the census metropolitan area of Ottawa-Gatineau (Ontario/Quebec) is divided into two areas: Gatineau part and Ottawa part.

a result of declines in Ontario, Alberta and British Columbia.

After four consecutive monthly declines, the value of multi-family permits increased 10.6% to \$1.1 billion. A significant increase (in dollars) in Ontario was enough to offset declines in seven provinces and three territories.

Municipalities approved 13,777 new dwellings in December, a number similar to the previous month. Of these, single-family units were down 9.4% to 6,030, while multi-family units were up 9.3% to 7,747.

Non-residential: Industrial component tempers overall decline

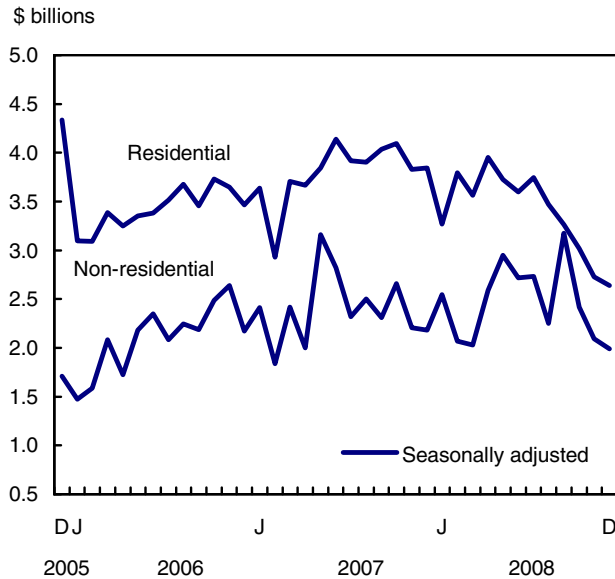
In the industrial component, the value of permits increased to \$419 million, up 30.4% from November. This followed two months of double-digit declines. The increase resulted mostly from construction intentions for manufacturing buildings in Quebec.

The gain in industrial permits tempered declines in the other two components.

In the institutional component, intentions fell 16.8% to \$501 million, the third consecutive monthly decline. Increases in eight provinces were offset by a significant decrease in Alberta, the result of lower intentions for medical projects.

In the commercial component, the value of permits fell 8.5% to \$1.1 billion, a third consecutive monthly decline. December's decrease came mainly from lower demand for recreation and warehouse building permits in British Columbia.

Provinces: Most significant declines in Alberta and British Columbia

The most significant decreases in December occurred in Alberta and British Columbia. In Alberta, the value of permits fell 27.0% to \$761 million, as a result of declines in all components of the residential and non-residential sectors.

In British Columbia, permit values declined 40.9% to \$358 million as a result of decreases in the residential sector and the commercial component.

In contrast, Ontario reported increases in total permit values, mainly a result of gains in

multiple-family permits and in all three components of the non-residential sector.

Quebec also reported an increase, the result of higher values in non-residential components and single-family permits.

Declines in most census metropolitan areas

The total value of permits declined in 21 out of the 34 census metropolitan areas in December. The largest declines (in dollars) occurred in Calgary, Vancouver and Ottawa, as all three experienced decreases in both residential and non-residential construction intentions.

In Toronto, the increase came from the residential sector where the value has tripled for multiple-family permits.

Stocks of grain

December 31, 2008

As of December 31, total stocks of most major grains and oilseeds were well above year earlier levels. Total stocks (including commercial and on-farm inventories) rose as a result of strong crop production in 2008.

Total stocks of canola were up 23.6% from December 31, 2007, to 9.1 million metric tonnes. This increase was a result of record production in 2008.

All three Prairie provinces reported record on-farm stocks of canola.

Farmers reported that total stocks of dry field peas rose 76.4% from December 31, 2007, to 2.6 million tonnes. The increase was the result of record field pea production in 2008.

On-farm stocks rose in all three Prairie provinces. Total Canadian on-farm stocks more than doubled from December 31, 2007, to 2.4 million tonnes.

Note to readers

The December farm survey of 11,500 Canadian farmers is a survey of Canadian field crop stocks conducted from January 2 to January 9, 2009. Farmers were asked to report the amounts of grain, oilseeds and special crops in on-farm storage.

Data on commercial stocks of western major crops originate from the Canadian Grain Commission. Commercial stocks of corn and soybeans are estimated by a Statistics Canada sample of grain elevators in Eastern Canada.

Data on commercial stocks of special crops originate from a survey of handlers and agents of special crops.

National supply-disposition tables for the major grains and special crops are included in this report and will be included in future production and stock reports. Methodology details are published annually in the October issue of *Cereals and Oilseeds Review* (22-007-XIB, free).

Farm product prices

December 2008

Prices received by farmers in December for grains, oilseeds, specialty crops, potatoes, cattle, hogs, poultry, eggs and dairy products are now available.

The December Alberta feeder steers price was \$88.03 per hundredweight, down 5% from November. However, it was up 1% from December 2007 when the price was \$86.85.

The Ontario wheat price in December was \$156.45 per metric tonne, down 3% from November. The wheat price in Ontario has fallen 41% from December 2007 when it stood at \$265.43.

Canadian Survey of Experiences with Primary Health Care

2008

The microdata file from the 2008 Canadian Survey of Experiences with Primary Health Care is now available.

This survey, sponsored by the Canadian Institute for Health Information and the Health Council of Canada, provides national and provincial information on the experiences of Canadians with primary health care.

Its purpose was to measure experiences with the healthcare system, in particular with access and utilization of various types of primary health care services. Respondents were asked about visits with various doctors and clinics, emergency rooms as well as their prescription medication use. Special attention was given to people living with chronic conditions.

The information gathered in this survey refers to the 12 months leading up to the interviews, which were conducted from April to June 2008. The sample consisted of 16,482 adults in the 10 provinces and 3 territories.
