“Noongom Anishinaabewigiizhigad, kii-nandawenimigoom ji-wiidookaazoyeg wijiikamigak endaswewaanagiziwaad Anishinaabeg, Eshkiimeg gaye Wiisaakodewininiwag, minik gegoo gaa-ozhitoowaad gaye ezhi-gikendaasowaad. Endaso-niibin owe inakamigad gii-maajiseg niibin, mii owe genoogiizhigak. Mii owapii naagwatooyang gidanishinaabewichigenaanin, miziwe omaa Zhaaganaashiiwakiing [gegiinawaa gidaa-wijitoonaawaan](#) enakamigak ogowe Anishinaabeg ezhitwaawaad, ji-gikendaman ezhitwaawaad Anishinaabeg gaye gaa-toodawindwaa mewinzha.

Apii Ode'imini kewigiizis 21st, mii ini niizing inakamigak owe *United Nations Declaration on the Rights of Indigenous Peoples Act* ji-dibendamowaad Anishinaabeg Ogimaawaadiziwin, mii owe ge-oko-anokaadamang ezhi-anishinaabewiyang ji-gaasiibijigaadeg maazhidoodaadiwin weweni ji-wiidanokiindiyang ji-manaaji'idiyang ezhi-gwayakoseg gegoon. Giga-oko'idimin ji-dazhindamang weweni endaswewaanagiziwaad Anishinaabeg omaa akiing, endaswewaanagiziwaad Anishinaabeg ji-noondawindwaa. Ji-dazhindamang gwayakochigewinan gaye maazhichigewinan owedi gaye wemitigoozhi omaa izhichigewinan. Zhaaganaashii Ogimaa da-wijitwaa ji-wiji'aad Anishinaabe' ji-oko-noojimoyang endaswewaanagiziyan omaa akiing, miziwe owe da-inakamigad enigokwaag Zhaaganaashiiwaki.

Owe apii jiikamigak, ji-naagwatooyang ji-oko-wijj'idiyang weweni ji-wiindanokiindiyang omaa miziwe Zhaaganaashiiwakiing. Gaye enweyang ge-anishinaabemoyang, gaye anishinaabewitwaawinan Eshkiimeg, Wiisaakode-anishinaabeg. Daga sa naa weweni bizindawaadaanik ezhitwaawaad Anishinaabeg omaa akiing; gaye bizindawaanaanik ekidowaad gaye ezhijiikakamigiziwaad niimi'iding; gidaa-adaawemin mink gegoo gaa-ozhitoowaad Anishinaabeg daabishkoo mazinigwaasonan.
