Pre-filing validation	Validate basic filing information before transmitting a complete T2 return. This service identifies and returns any errors that will prevent the electronic filing of the T2 return. It can be used before, or at any point during, the preparation of the T2 return.	,

View mail online	View items the CRA has sent you, such as your Notice of Assessment. This is available for all authorized viewers of the BN, even if not registered for email notifications. If you want email notifications to alert you to new online mail, provide your email address on the T2 return, or register up to 3 emails in MyBA or RaC under Manage notification preferences. Note: If an account registers for email notification, the CRA stops mailing paper versions of those items that are viewable online.		•
