### Qanuq piniaqigut ikayuuhiatit ihuaqtikhatilu?

Ilvit nulialu inuuqatiloniit iniqtiriaqaqtatit itkamtaksiliqijutitit tikitinagu Qittiqqautijuuq 30 aipagutuaraagat pivaviaqni ikayuuhiaqhanik ihuaqutiniklu pilaaqtaqnik, manikhatilu taksiyautiqagitkaluaqata aturiaqaginiganiqniklu piqagininuviluniit manikhaakhaqnik. Nunaqaruvit Quebec-mi, iniqhiyariaqaqtutulu nunaqyuaqni itkamtaksiliqijutitit. ### Qanuq akituniganik pinialuaqiaq aipaagutuaraagat?

**CCB** – uvuga **\$7,437** atuni nutaraq nukaqhiyuq 6-nik ukiunit agayukhiyunulu **\$6,275** atuni nutaqami ukiuqaqtumik 6-mit 17-mut. Uuktujavutit tamainik nutaqanik munaqtaqnik uuktuqhimaginiruvit hivuani kinaluliqaa pihimaginiqata ukuniga nutaqanik pijutayunik. Ihuaqtigijavatit nutaqiqijutit akiliqhimayatit uumuga Kinamuliqaa munaqtmik nutarariyaqnik.

**GST/HST ihuaqut** – uvuga **\$496** ilaulaaqtumi inukmi uvugalu **\$992** ilaulaaqtumik inuuqatiriiknik malrukniq nutaraqaqtumik.

**Kanatami havaktut ikayuuhiaqut** – uvuga **\$1,518** ilaulaaqtumi Inukmi uvugalu **\$2,616** ilaulaaqtumi ilagiini. Una utuqtukhat ihuaqut mikjikutiyyuq itkamtaksinik atugriyanik hivuliqmi avaliqtulu ihuaqtutit utiqtitavaktut iliknut.

Avaliituuniruvit iniqniuguvit atugaqaruvit akiliqtakhanik iniqtigakhaniklu havauhikhaqni ukunuga, ilituriyutit tamaita 1-talat aturiaqaaqnginik.
