

Use the following charts to calculate the amounts to report on Form PE428, Prince Edward Island Tax and Credits. Keep this worksheet for your records. **Do not attach it to your return.**

### Line 5808 – Age amount (if born in 1953 or earlier)

If the amount from line 236 of your return is:

- **\$28,019 or less**, enter \$3,764 on line 5808 of your Form PE428
- **more than \$53,112**, enter "0" on line 5808 of your Form PE428

Otherwise, complete the following calculation:

Enter on line 5844 of Form PE428 \$6,890 **plus** the amount from line 5 (maximum \$10,909), **unless** you are completing this chart to calculate the amount at line 5848.

**Line 5848 – Disability amount transferred from a dependant**

Complete this calculation for each dependant.

**Note**  
If you and your dependant were not residents of the same province or territory at the end of the year, special rules may apply. Contact the Canada Revenue Agency to find out how much you can claim.

**Line 5872 – Allowable amount of medical expenses for other dependants**

Complete this calculation for each dependant.

**Line 6152 – Prince Edward Island dividend tax credit**

Calculate the amount to enter on line 6152 of Form PE428 by completing **one** of the following calculations:

- If you entered an amount on line 120 of your return but **no amount** on line 180, complete the following:

Enter this amount on line 6152 of Form PE428.

**Line 78 – Prince Edward Island political contribution tax credit**

If your total political contributions (line 77 of Form PE428) were **more than \$1,150**, enter \$500 on line 78 of Form PE428.

If **not**, use the amount on line 77 to decide which column to complete.
