



## Application to Certify a Religious Sect or a Division of it so Members can Apply to Exempt their Self-Employed Earnings from the Canada Pension Plan

Use this form if you are the authorized spokesperson for a religious sect or division of a religious sect and you are **applying to certify** the sect or division and to receive a registration number. This certification is a prerequisite for members of the sect or division who **apply to not have to pay** into the Canada Pension Plan (CPP) on their self-employed earnings.
