



# Election or Revocation of an Election to Have the Joint Venture Operator Account for the Fuel Charge

under Part 1 of the Greenhouse Gas Pollution Pricing Act

A joint venture is a "person" for purposes of the Greenhouse Gas Pollution Pricing Act (the Act). However, the Canada Revenue Agency does not issue a business number to a joint venture and as a result each participant in a joint venture would account for its proportionate share of the fuel charge, unless an election is made to elect a joint venture operator that accounts for the joint venture.

Do not use this area.

Use this form if you are a participant **and** the operator of a joint venture and you are jointly electing with other participant(s) (co-venturer(s)) to make yourself responsible to account for the fuel charge for the joint venture. You can also use this form to revoke a previous election. This form must be completed by each co-venturer that wishes to jointly elect with you. If there is more than one co-venturer, add another page containing the information in Part 1 for each additional co-venturer.

A joint venture election can be made if **all** the following criteria are met:

- the joint venture is not set up as a partnership, corporation, or trust;
- the operator is a participant in the joint venture;
- there is a written agreement governing the joint venture; and
- the operator is a registrant under the Act (however, the co-venturer(s) does not have to be a registrant under the Act to make the election).

If you do not have written authorization from the co-venturer to complete and certify this election or revocation on their behalf, both the operator and the co-venturer have to sign this form. If you have written authorization from the co-venturer to complete and certify this election or revocation on their behalf, the co-venturer does not have to sign this form.

Do **not** send us this form. If you do not have written authorization from the co-venturer to complete and certify this election or revocation on their behalf, the operator and the co-venturer(s) have to keep a copy with their records.
