Line 6 of Form TD1PE – Spouse or common-law partner amount		
If your spouse or common-law partner's estimated net income for the year (including the income earned before and during the marriage or common-law relationship) will be between \$778 and \$8,558, calculate your partial claim as follows:

Your spouse or common-law partner's estimated net income for the year	-	2
Line 1 minus line 2 (maximum \$7,780, if negative, enter "0")		3
Enter this amount on line 6 of Form TD1PE.		=
Line 7 of Form TD1PE – Amount for an eligible dependant		
If your dependant's estimated net income for the year will be between \$778 and \$8,558, calculate your partial claim as follows:

Line 1 minus line 2 (maximum \$7,780, if negative, enter "0")		3
Enter this amount on line 7 of Form TD1PE.		=
Line 8 of Form TD1PE – Caregiver amount		
If your dependant's estimated net income for the year will be between \$11,953 and \$14,399, calculate your partial claim as follows:

Line 1 minus line 2 (maximum \$2,446, if negative, enter "0")	=	3
Enter the amount you claimed for this dependant on line 7 of Form TD1PE.	-	4

Enter this amount on line 8 of Form TD1PE.		=
Line 9 of Form TD1PE – Amount for infirm dependants age 18 or older		
You cannot claim this amount for a dependant for whom you claimed the caregiver amount on line 8 of Form TD1PE. If your dependant's estimated net income for the year will be between \$4,966 and \$7,412, calculate your partial claim as follows:

Enter the amount you claimed on line 7 of Form TD1PE for this dependant.	-	4
