



# Provincial Tuition and Education Amounts

**Schedule PE(S11)**

T1 General – 2016

**Only the student** must complete this schedule and attach it to his or her return. Use it to:

- calculate your P.E.I. tuition and education amounts to claim on line 5856 of your Form PE428;
- determine the provincial amount available to transfer to a designated individual; and
- determine the unused provincial amount, if any, available for you to carry forward to a future year.

To do this, you have to **designate** the individual and **specify the provincial amount** that you are transferring to him or her on Form T2202A, TL11A, TL11B, or TL11C. Enter the amount on line 20 below.

**Note:** If you have a spouse or common-law partner, special rules may apply. Read line 5856 in the forms book.

If you resided in Quebec, use the federal tuition, education, and textbook amounts. Otherwise, use the **lesser** of the provincial, territorial, and federal amounts.
