



## 2017 Ontario energy and property tax credit (OEPTC) - Calculation sheet for single individuals who have no children

Use this calculation if you were **under the age of 64** and single on December 31, 2016, and you do not have the care of a child who is under the age of 18 on the first day of the payment month.

You may have to use a different calculation sheet for a particular month if you become a parent of a child under the age of 18.

If your annual OEPTC amount plus, if applicable, your annual Ontario sales tax credit and Northern Ontario energy credit is:

- \$2.00 or less, no payment will be issued.
- from \$2.01 to \$10.00, you will receive one payment of \$10.00.
- \$360.00 or less, you will receive it in one payment instead of monthly.

The first monthly 2017 Ontario trillium benefit payment, which includes any OEPTC entitlement, will be issued on July 10, 2017.

However, if you made a choice on your 2016 return to wait to receive your 2017 OTB entitlement, it will be issued on June 10, 2018.
