8. Jurisdiction is determined using the jurisdiction code on the T2 return (line 750).

10. The category "Large" includes all corporations with total assets of more than \$15 million. All other corporations are classified as "Small and Medium" corporations. Corporations that did not file a balance sheet (Schedule 100 or Schedule 101) are classified as "Missing".

12. Prescribed federal Crown corporations are placed in the "Outside Canada" jurisdiction if they do not pay provincial income tax.
