9. The category "Large" includes all corporations with total assets of more than \$15 million. All other corporations are classified as "Small and Medium" corporations.  
Corporations that did not file a balance sheet (Schedule 100 or Schedule 101) are classified as "Missing."
10. Counts include tax-exempt and inactive corporations.
11. Prescribed federal Crown corporations are placed in the "Outside Canada" jurisdiction if they do not pay provincial income tax.
