

2024 Ontario energy and property tax credit (OEPTC) - Calculation sheet for married or common-law seniors who have or do not have children

Use this calculation if you had a spouse or a common-law partner and either of you were **64 years of age or older** on December 31, 2023. This calculation applies whether you have children or not.

Note

If only one of you is 64 years of age or older on December 31, 2023, that spouse or common-law partner **has** to apply for the credit for your household.

If your annual OEPTC amount plus, if applicable, your annual Ontario sales tax credit and Northern Ontario energy credit is:

- \$2.00 or less, no payment will be issued.
- from \$2.01 to \$10.00, you will receive one payment of \$10.00.
- \$360.00 or less, you will receive it in one payment instead of monthly.

The first monthly 2024 Ontario trillium benefit payment, which includes any OEPTC entitlement, will be issued on July 10, 2024.

However, if you made a choice on your 2023 return to <u>wait to receive</u> your 2024 OTB entitlement, it will be issued on June 10, 2025.
