- 2. Number of applications and applicant province of residence are obtained from the Canada Recovery Benefit (CRB) file.
- 3. Figures are stated for applicants who applied for the CRB through Canada Revenue Agency's (CRA's) My Account portal and the Interactive Voice Response system. These figures also include manual applications.
- 4. Applicants whose residence is outside of Canada are grouped in the category 'Outside Canada.' Applicants must reside and be present in Canada during the period(s) for which they are applying.
- 5. Applicants who do not have a valid province of residence registered within CRA systems are grouped in the category 'Missing.'
- 6. The gross amount is the total before taxes are withheld. The CRA withholds a 10% tax at source for each CRB payment issued.
- 7. All counts are rounded to the nearest ten and all amounts are rounded and in thousands of dollars. The sum of the data may not add to the total, due to rounding and/or suppression.
