SIU Authorizations: April 1st 2024 – June 30th, 2024 (Quarterly Report Q1)

National SIU authorization counts increased in the first quarter of 2024-2025.

Background

Structured Intervention Units (SIUs) were incorporated into the Correctional Service of Canada (CSC) on November 30th, 2019. Such units are intended to provide intervention-focused accommodations to offenders who cannot be safely managed in the mainstream offender population. As part of a quarterly series highlighting trends in SIUs, the current analysis examines SIU data drawn from CSC's data warehouse for the first quarter of 2024-2025 (i.e., April 1st, 2024, to June 30th, 2024).

Overview of Authorizations

In Q1 of 2024-2025:

- There were 745 new authorizations to an SIU, an increase from the past three quarters (the average number of quarterly authorizations in 2023-2024 was 722).
- The average number of new monthly authorizations in Q1 was 248, representing around 1.8% of the in-custody population.
- Most (95%) authorizations occurred at men's institutions.

Regional Trends

Average monthly SIU authorizations in Q1 represented 2.1% of the in-custody population in the Atlantic region, 3.0% in the Quebec region, 1.7% in the Ontario region, 1.1% in the Prairie region, and 1.2% in the Pacific region. Most SIU authorizations in all regions except Ontario commenced at an SIU site rather than a Restricted Movement (RM) site.¹ In the Ontario region, 72% of authorizations commenced at a RM site.

Authorization Reason

In Q1, 53% of authorizations were justified under 34.1 A (security) of the <u>Corrections and Conditional</u> <u>Release Act (CCRA)</u>, while 45% were justified under 34.1 B (safety). Authorizations justified under 34.1 C (investigation) remained relatively uncommon.

Service correctionnel

Consistent with prior periods, there was regional variation in regards to authorization reason trends (e.g., 34.1 A authorizations were most common in Quebec; See Table 1).


*Most incidents occurred at Collins Bay Institution (an RM site) and did not result in transfer to an SIU site.

Discussion

SIU authorization counts increased in the first quarter of 2024-2025; trends remained marked by regional variation. Authorizations remained highest in the Quebec region, with the majority justified under 34.1 A (security) of the *CCRA*.

¹Not all institutions have an SIU. Inmates who are incarcerated at a non-SIU site who have been authorized to transfer to an SIU can be subject to restricted movement for up to five working days. See: *Commissioner's Directive 711*.
