(1) Household Income is the aggregate gross income, in whatever form received, of all members of the household, or of an individual, where applicable. Additional individuals who are not counted as part of the occupant of record Household Size may reside in the RHU (CFHA must be advised). Where this occurs, those individuals must be included in the calculation of Gross Household Income that must be used to determine eligibility for the 25% shelter charge limit

(a) All pay and monthly allowances are included in the determination of gross household income. This includes, environmental allowances, specialist allowances, and/or post-living differential. You must also include all other sources of income including (but not limited) other employment income and/or income from government sources including EI, OAS, CPP, and QPP benefit, etc.

(b) The limit of twenty-five percent (25%) of gross household income applies to the full monthly shelter charge only. Charges for trailer pads, parking, fuel and utilities are not factored into the monthly shelter charge calculation. * Garages that are not linked to a specific Residential Housing Unit and rented separately are deemed parking charges and are not to be included in the monthly shelter charge.

(2) Gross household income excludes:

- a. Earnings of children, or funds for the tuition of children in regular attendance at recognized institutions of learning such as scholarships, bursaries and contributions from non-resident family members,
- b. Earnings of a working spouse or common-law partner up to the amount that may be claimed as a "spousal amount" as specified in the Federal General Income Tax and Benefit Guide, as amended from time to time (\$13,808 2021-22; \$14,398 2022-23 and \$15,000 2023-24); and
- c. The Canada Child Benefit (CCB) as it is a non-taxable benefit.

(3) Income must be supported by current, relevant documentation which may include current pay statements from all household occupants, receipts from government benefits and allowances and/or receipts for all other sources of income. A CRA Proof of Income Statement (POIS) or Notice of Assessment (NOS) may be accepted if it provides the most up-to-date information of all income sources.

(4) An application must be submitted annually using this form as all reductions cease on March 31st each year. The occupant of record must be full time employed in order to apply.

(5) IMPORTANT: If your monthly shelter charge no longer exceeds 25% of your gross household income, you will no longer be entitled to this reduction and the full (new) shelter charge is applied on April 1st. There is no provision to limit this increase (which could be quite significant) to the \$100 limit outlined in QR&O Vol IV, Appx 4.1 as this increase is not a shelter charge increase; this increase is a result of an ineligibility of a previous benefit and not an increase to the appraised monthly shelter charge.

Declaration

I certify that the information herein provided is accurate and complete to the best of my knowledge. I acknowledge that incomplete or inaccurate information may result in my application being denied.
