



Compliance Unit Trading System (CUTS)

Annual report form for companies generating compliance units

If you submitted a notification of generation of compliance units under the Compliance Unit Trading System (CUTS), **you must submit an annual report by March 1** of the year following when you generated them to Environment and Climate Change Canada (ECCC).

How to report:

Use this annual report form for each product that you have notified to generate compliance units. Your report must include information on (but is not limited to) the actual quantities, concentrations of your reformulated products, compliance unit calculations, and confirmation of whether you intend to continue generating compliance units for the next calendar year and the quantities you expect to manufacture or import. Actual quantities can be calculated using the following formula:

- Actual quantity = manufactured quantity + imported quantity – exported quantity

If your company has submitted generation notifications for multiple reformulated products, please submit sections 3 and 4 for each notification.

Refer to sections 7 to 14 of the regulations to ensure all necessary information is provided and that you understand your responsibilities under the CUTs program.

Timelines:

You must submit your report by March 1 of each year to obtain compliance units for the preceding calendar year. For example, if you submitted a form to generate compliance units in 2027, you would need to submit a report for the 2027 calendar year by March 1, 2028. If this report demonstrates the requirements of the notification were met, you will be eligible to generate compliance units from the date of your notification to the end of the calendar year in which the notification was made.

ECCC will provide you with a confirmation that you have balanced your compliance units and the number of compliance units that are available within 60 days after the day on which you submit the annual report. Compliance units whose availability is confirmed are valid for two years beginning on January 1 of the year following the calendar year in which they are generated.

Confidentiality:



Under section 313 of the Canadian Environmental Protection Act, all persons submitting information to the Minister are entitled to submit a written request that specific information be treated as confidential. Persons submitting such a request should also include the reasons for that request. Under each section of this application, you may request information be treated as confidential. You have been given space to provide your explanation. If you need more space, please attach added documents.
