- Specimens are exchanged with other CITES-registered institutions (if the other institution is not registered by CITES, CITES Export and/or Import Permits must be used). Please refer to 'CITES Registers' at <u>www.cites.org</u> for the list of CITES registered scientific institutions.
- Specimens are herbarium or other preserved, dried or embedded museum specimens, live plant material, or frozen museum specimens that are currently part of the institution's collection; and
- Exchange of specimens is for scientific purposes.

- **The applicant must sign the application form.** The applicant must be a resident of Canada or a representative of a scientific institution with an office in Canada AND must be knowledgeable of the contents of the shipments made by the institution.
- If the application is approved, confirmation of registration of the scientific institution including certificates and
 instructions will be sent by mail to the applicant If you would like to receive your permit by courier, please provide a prepaid envelope or your courier account number. The permit will be sent to the address provided in Section 2, unless
 otherwise specified by the applicant.
- Import and export of animals and plants and their parts and derivatives is also controlled by the *Plant Protection Act* and the *Health of Animals Act* implemented by the Canadian Food Inspection Agency (CFIA).
