kâ-itôtahkik, kanâta oski okimânâhk kinwâpahtamwak kîkway kâkîpimipayihtâyahk-ka-osihtâhk e-sohkahk, ayiwâk tipeyimisowin, sâsîpihtamowin sôniyâwewin. nipapâsi waskawânân ka-wîcihâyahkik meskatônîkewin wîtahpisowak akâmaskehk ekwa ka-osihtâhk ka-sohkisiyahk mîkiwâmihk. nitatoskâtenân kwayask sôniyâw pimipayihcikewin ekwa ka-sihtoskawihcik kanâta ayisiyiniwak mistahi kâhâyamihocik ohci tahto kîsikâw masinahikewina-anohc ka-wîcihihcik ekwa âsôwi pimohtâkan wâpahki ka-miywâsik.

ekota Budget 2025, nimasinâhenân niwawewinân ka-osihtâhk kanâta maskawisewin. ikospî ekota, nipapâsi osihtânân anima *kâ-mâci* misâk wikamik, wâskahikana, ekwa misi-atoskewina kâ-ohpikik kanâta sôniyâwewin ekwa ka-osihtâhk kinwes miyo pimâtisiwin; *ka-wîcihihcik* kanâta ayisiyiniwak asici miywâsiki atoskewina ekwa ka-kaskihtâhk ka-tipahamihk pimâtisiwin; ekwa kanaweyihtamihk kimâmawinitowiniwa, eta kâ-wîkiyahk askiy, ekwa kâ-esi pimâtisiyahk.

nikaskihonân tâpwe mâwacihcikana ohci kanâta ayisiyiniwak eta mîna sihtoskamihk misawe itôtamowina ekwa kanaweyihtamihk sôniyâw atâwewina eta ka-kaskihohk kîkwaya. nikanaweyihtenân e-sohkahk sôniyâw nîpawin asici anima miyoskamin sôniyâwewin wihtamâkewin 2026 eta e-wâpahtamihk masinahikewina nakoc nihcâyihk anima sôniyâw itâpowin ekwa niwînakiskenân nisôniyâwewin sakâpekahpiticikana.

anima miyoskamin sôniyâwewin wihtamâkewin 2026 anima kotak itôtamowin niwaweyinân ka-osihtâhk *e-sohkahk kanâta ohci kahkiyaw*. astew e-sâponâkwahk wihtamâkewin ohci anima kâ-sohkahk kanâta sôniyâwewin, e-miyihcik kanâta ayisiyiniwak niwawewinân. wîcihihtâsiwimakan ta-kaskihtâhk ka-tipahamihk kîkwaya eta kâ-wîkihik, sihtoskawihcik atoskewiyiniwak ekwa ka-papâsi osihtâhk wâskahikana ekwa kâ-misâki wikamikwa. sohkasikâtew mîna kanâta mônîhkewin ekwa sôniyâwewin ohpikiwin eta mîna e-osihtâhk e-sohkahki ekwa kanaweyihtâkwahki mâmawinitowina misawe askîhk.

kanâta oski okimânâhk e-meskociwepinimihk kisôniyâwewinaw ohci mamiôtamâkewin isi maskawâtisiwin. anima miyoskamin sôniyâwewin wihtamâkewin 2026 kihcinâhowin kahkiyaw kanâta ayisiyiniwak kâkîwîcihihtâsiwak ka-osihtâhk e-sohkahk kanâta ekwa ka-mâtinamâkecik ekota kaskihowin :



- **animakanâta sohkahk sôniyâwewin**—kanâta mâci nistam misawe tipeyimisowin sôniyâw kanaweyihcikan. ôma ka-tipahakehk isi kihcinâc kanâta atoskâcikana ekwa atoskahewikamikwa. kanâta ayisiyiniwak ka-wîcihikiwak ohci ôhi askiy osihcikan atoskâcikana isi atoskewina, sôniyâwewin ohpikiwin, ekwa ayiwâk kanaweyihtâsiwin, anima okimânâhk kihcinâhohk kanâta ayisiyiniwak wîstwâw ayâwak kîkwaya ekota atoskâcikana wiyâwâw. eyikwânima ohci pîtos ekwa misteyihtâkwahk âpacihcikan ohci anima kanâta kâ-sohkahk kanaweyihcikan anima ka-oski atâwâke tipahikan âpacihcikan. eyako ôma pakitinikiwak kanâta ayisiyiniwak ta-kahtinahkik sôniyâwa ekota osihtâyâhki kanâta kâ-sohkahk kiyânaw.
- **mâmawâtoskewak kanâta kâ-sohkahk**-peyak oski misawe askiy wihkohkamâtowin ta-kahtinehcik, kiskinwahamawihcik, ekwa atoskahihcik 80,000 isko 100,000 oski nakacihâtâwak atoskewak ikospî 2030-31. ôma atoskewin osihcikeyimakan oski atoskewina ohci kanâta ayisiyiniwak ekwa pihtikwepitâwak atoskewiyiniwak kâ-nitaweyimihcik ka-osihâtâhk ayiwâk wâskahikana ekwa misi atoskewin ayiwâk ekwa kâ-ispihcâki.
- **Osihtâhk e-sohkahki-kanaweyihtâkwahki mâmawinitowina**-ka-osihâtâhk mâmawinitowina kanaweyihtâkwahki, ayiwâk wîtahpisômakahki, ekwa ayiwâk maskawâtahki. ayiwâk nitosihâtânân wâskahikana, ayiwâk e-sohki paminamâhk misihowina ekwa kimitowin, ekwa tipahamihk wikamikwa, mîna apisâsiki nipiy ôsi nakinikewina eta kihcikamik mâmawinitowina ekwa cîki ekotawihk atoskewina. mîna nitipahenân ka-osihâtâhk miywâsiki, kanaweyihtâkwahki, ekwa sohkahki iyiniw mâmawinitowina.

ôta ôma wihtamâkewin, niwihtenân kwayask sâpo wâpahtamowin wihtamâkewin tânisi kisôniyawewin esi pimakotek mekwâc eyikohk kâ-esi pîtosipayik kitaskenaw. misteyihtâkwan ôma ka-ohpinamihk moy kihcinâhowin, wîcihikocik atoskewina ka-kahtinahkik oski atoskewina ekwa peyakoskâna ka-waweyicik ohci nîkânihk.
