At its November 19, 2024, meeting, the Farm Products Council of Canada (Council) reviewed the proposed amendments to the *Canadian Turkey Marketing Quota Regulations, 1990*, as outlined in your letter of October 2, 2024, for the 2024-25 control period, which begins on April 28, 2024, and ends on April 26, 2025.

Following a thorough review of the rationale provided by Turkey Farmers of Canada (TFC) and internal analysis, Council members found that the amendments are necessary for the implementation of the marketing plan as contained in the *Canadian Turkey Marketing Agency Proclamation*. Council recognizes that these amendments are required to finalize of the 2023-24 control period reconciliation and apply the Export Policy carry-forward to the current 2024-25 control period.

This amendment to the 2024/2025 Schedule to the Canadian Turkey Marketing Quota Regulation reflects the decision of the Turkey Farmers of Canada (TFC) Directors at their meeting of September 25, 2024, to set Carry-Forward allocations under Section 1 of the Export Policy following the finalization of the 2023/2024 Control Period Reconciliation. The rationale for revising the federal quota for inter-provincial and export trade of turkey to 168,662,567 kg for the 2024/2025 Control Period is detailed in the following sections.

3) Proposed Amendment: Section 1 Export Policy – Allocation of Carry-Forward

In accordance with the TFC Export Policy and the finalization of the 2023/2024 Control Period Reconciliation, it is necessary that the 2024/2025 Allocation be amended so that 2,852,695 kg be allocated to the provinces of British Columbia, Alberta, Saskatchewan, Manitoba, Ontario, and Quebec. Under the terms of the TFC Export Policy (Section 1.09), Provincial Boards are permitted to carry-forward one-sixth of Export Policy Utilizations earned in a control period to the following control period, if it has not already been used to cover production. This provision provides the industry with flexibility, as production can be timed to occur when practical.

4) TFC Policies and Statutory Obligations

This amendment is in response to the finalization of the 2023/2024 Control Period Reconciliation and terms of the TFC Export Policy.

5) Revised 2024/2025 Federal Quota
