

## Applying for a research licence checklist

This checklist can be used by applicants applying for a research licence. It does **not** need to be submitted as part of your research licence application. For the document naming convention, your application number (APP #) is available after you've created a licence application in the Cannabis Tracking and Licensing System (CTLS).

### Section 1: Before you apply

Determine if you need a research licence

Determine your licence model (project-based or institution-wide)

#### Project-based:

- Single (one protocol, one site)
- Single (one protocol, multiple sites)
- Multiple (more than one protocol, one site)

#### Institution-wide:

One institution, one site

Determine your study risk category (applies to non-therapeutic research on cannabis (NTRC) applications only)

Familiarize yourself with the legislation

If you intend to self-identify as an Indigenous or Indigenous-affiliated applicant, you may contact the Indigenous Navigator Service at <a href="mailto:navig@hc-sc.gc.ca">navig@hc-sc.gc.ca</a> for additional guidance on the application process

Know what business supports apply to you

Prepare your site

Identify the following people

- Licence holder (if the application is for an individual)
- Responsible person
- Alternate responsible person (if applicable)
- Associated people (if applicable)
- Directors (only if applicant is a corporation, cooperative or partnership)
- Officers (only if applicant is a corporation, cooperative or partnership)
