Section 4	Information on the qualitative composition of the preparation or mixture has been included (Sections 48(1)(c)(ii) and 76(1)(c)(ii) of the PCR).
Section 5	Information on the quantitative composition of the preparation or mixture has been included (Sections 48(1)(c)(ii) and 76(1)(c)(ii) of the PCR).
Section 6	Information on the physical properties of the preparation or mixture has been included (Sections 48(1)(c)(iii) and 76(1)(c)(iii) of the PCR).
Section 7	Information on the chemical properties of the preparation or mixture has been included (Sections 48(1)(c)(iii) and 76(1)(c)(iii) of the PCR).
Section 8	Information on the analytical method for purity and stability has been included (Sections 48(1)(c)(iv) and 76(1)(c)(iv) of the PCR).
