ADMISSIBILITY

The CLC is responsible for screening your eligibility only and Immigration, Refugees and Citizenship Canada (IRCC) will render a final decision on eligibility and will undertake an assessment of your admissibility to Canada. Under this public policy, you must not be inadmissible to Canada for reasons other than overstaying your temporary resident status and working without a valid work permit.
