### Background about the Indigenous Off-Diesel Initiative

The Indigenous Off-Diesel Initiative (IODI) is a clean energy training and funding program that supports Indigenous-led climate solutions in remote Indigenous communities that currently use diesel for heat and power.

IODI was first launched in 2019 and was designed based on 18 months of engagement with Indigenous communities, rights holders, and organizations. It is delivered in collaboration by the Indigenous Clean Energy Social Enterprise (ICE SE) and the federal government.

IODI supports a cohort of participants (who we call Energy Champions) in their journey – from training through to project implementation. Energy Champions are encouraged to work closely with a team of clean energy leaders and to engage with their communities to support community energy literacy and ensure that projects reflect their community's priorities.

There are ten Energy Champions spots available in Cohort 2. Those who are selected have the opportunity participate in all three phases of IODI:

- 1. Clean Energy Training through the 20/20 Catalysts program: Summer 2023 \$25K in funding
- 2. Community Engagement and Clean Energy Planning: Fall 2023-Spring 2025 \$500K in funding
- 3. Project Implementation: Spring 2025 onwards Up to \$1M in funding

Energy Champions, with the support of their teams and communities, must fully complete each phase before they can move onto the next. The federal government and ICE SE will support participants in

completing each phase and accessing resources, while being responsive and flexible to community priorities.

Interested individuals and teams are encouraged to reach out with any questions about the program before the deadline.

### Participation Requirements and 20/20 Catalysts Training

To join the 2022/2023 cohort, you must be available to participate in the 20/20 Catalysts program delivered by Indigenous Clean Energy Social Enterprise from April-July 2023 or have already completed the 20/20 Catalysts program. For more information about the 20/20 Catalysts program, please visit the ICE SE website.

If you have already completed the 20/20 Catalysts Program, you are still eligible to apply. If you are selected to join the Initiative, you will complete a 2-day refresher course in Spring 2023 instead of participating in the full 20/20 Catalysts Program again.

By submitting this application, you will be automatically assessed for the 20/20 Catalysts program. You **do not** need to submit an additional 20/20 Catalysts application to ICE SE. If you would like to apply only for the 20/20 Catalysts program and not the Indigenous Off-Diesel Initiative, please apply on the ICE website.

Costs associated with travel to 20/20 Catalysts Program training sessions and in-person training and events are covered by the Indigenous Off-Diesel Initiative. Please let us know if you require any accommodations to support your participation in the program.

### **Eligibility Check List**

To be considered for the Indigenous Off-Diesel Initiative you must meet the following criteria:

- ✓ You reside in, or have very close ties to, a remote Indigenous community\* or group of remote communities.
- ✓ You are available to participate for the duration of the three-year initiative (2023-2026) which includes: setting up a project team, working with mentors, developing a community energy plan, leading community engagement, and planning a community renewable energy and/or energy efficiency project focused on reducing diesel and fossil fuel use for heat and/or power.
- ✓ You are able to participate in the three, weeklong sessions of the 20/20 Catalysts Program (April 30-May 5, 2023; June 11-16, 2023; and, July 23-28, 2023) or the 2 day refresher course in Spring 2023 (date to be confirmed) if you are a Catalyst alumni.
- ✓ You can attend at least one 3-day annual Gathering hosted by the Indigenous Clean Energy Social Enterprise that will take place every other year. The next Gathering is anticipated to take place in Spring 2024.

**Please note:** Priority will be given to applicants whose remote Indigenous community, or communities, do not already have federal funding for community-scale clean energy or energy efficiency projects.

Remote Indigenous communities involved in projects that will result in grid connection or connection to other sources of power (such as a major hydro project) within 5 years of the application deadline are **not eligible.** 

Individuals and communities who have already participated in the first cohort of IODI are not eligible.

#### \*What qualifies as a remote Indigenous community?

The community must have a majority Indigenous population that identifies as First Nation, Inuit and/or Métis; and,

The community must not be connected to the North American electrical grid or the natural gas pipeline network, and must be a permanent or long-term (5 years or more) settlement with 10 or more dwellings.
