SPOTLIGHT ON: THE OMBUDSMAN'S PROGRESS REPORT ON THE CANADIAN VICTIMS BILL OF RIGHTS



On November 25th, the OFOVC released the Ombudsman's <u>Progress Report on the CVBR</u>, after an in-depth examination and assessment of Canada's performance in upholding the rights that the Act provides. The Progress Report was informed by our frontline work, and the lived experiences of victims and survivors who have reached out to our Office in particular. In the report, the Ombudsman provides 15 evidence-based recommendations that could strengthen the Act and empower victims and survivors of crime.

EVENTS AND ENGAGEMENTS WITH STAKEHOLDERS (CONTINUED)



In October, the Ombudsman presented on the 2020 British Columbia Justice Summit Panel, which focused on alternatives to short-term incarceration. The Ombudsman participated to represent victims' rights and survivors' voices in the discussion, and discussed the wider use of restorative justice alternatives. The Ombudsman also gave a presentation on victimization and the law to Algonquin College Victimology students, sharing the many challenges victims face in accessing justice.

Following this, the Ombudsman and Executive Director met with the Honourable Carolyn Bennett to continue sharing perspectives and input from the OFOVC's Indigenous Advisory Circle (IAC), to support the development of the National Action Plan on Missing and Murdered Indigenous Women and Girls (MMIWG). They also met with the Honourable Bill Blair to discuss

Clare's Law, victims' services, police accountability,

and violence prevention. In a meeting with the Honourable David Lametti, the Ombudsman and Executive Director discussed the CVBR Statutory review, minimum mandatory penalties, and elder abuse.

To round out the month, the Ombudsman and Executive Director met with MP Randall Garrison, who introduced the Private Member's <u>Bill C-247</u>, which proposes to create a new criminal offence for controlling or coercive conduct in an intimate relationship. The OFOVC has actively called for the recognition of coercive control in the Criminal Code, and we commend MP Garrison's work.

To mark the start of Victims and Survivors of Crime Week on November 23rd, the Ombudsman delivered a Moment of Reflection. The theme for this year was Recognizing Courage, Renewing Commitment, and the Ombudsman commended the incredible courage and resilience of victims and survivors, service providers and frontline personnel for their incredible efforts. She also took the opportunity to renew her own commitment to pursuing a justice system that better meets the needs of victims and survivors of crime. In line with the theme of Renewing Commitment, the OFOVC held a launch event during Victims and Survivors of Crime week to mark the release of the Ombudsman's Progress Report on the Canadian Victims Bill of Rights (see page 2)!
