1	Manitoba applies the following policy to any publicly-funded vaccines: “Once eligible always eligible”, so individuals who do not receive a publicly-funded vaccine when it is first recommended are eligible to receive the vaccine anytime later (unless otherwise stated).
2	The influenza vaccine is offered free of charge on request for people aged 6 months and over.
3	Eligibility applies to those aged 60 years and older who reside in a personal care home (PCH), have been admitted to a PCH for respite care, or have been admitted to a transitional or chronic care unit while paneled for PCH (including those awaiting placement in a PCH).
4	High-risk criteria for RSV eligibility among individuals aged 60 years and older include being a resident of a long-term care home, Elder Care Lodge, or retirement home, including similar settings such as co-located facilities; being a hospital patient receiving alternate level of care (ALC), including comparable settings such as complex continuing care or hospital transitional programs; having glomerulonephritis (GN) with moderate to severe immunocompromise; receiving hemodialysis or peritoneal dialysis; being a recipient of a solid organ or hematopoietic stem cell transplant; experiencing homelessness; or identifying as First Nations, Inuit, or Métis.
5	Some people 27 years and older are eligible for the HPV vaccine free of charge, such as those with a chronic illness or weakened immune systems.
6	HPV vaccine is publicly funded for adults with risk factors placing them at increased risk of HPV infection.
