<p>The information requested is collected by the Controlled Goods Program to determine the current and ongoing entitlement of your company to register with the Controlled Goods Program. The information is collected under the authority of the <a href="#">Defence Production Act</a> and the <a href="#">Controlled Goods Regulations</a>.</p> <p>Refusal to provide personal information or the provision of incorrect information will result in you being prohibited from examining, possessing, or transferring items identified in the Controlled Goods List contained in the Schedule to the <i>Defence Production Act</i>.</p> <p>Your personal information is used, protected, or disclosed in accordance with the <a href="#">Privacy Act</a> and is described in the Personal Information Bank, Controlled Goods Program, <a href="#">PWGSC PPU 045</a>. Under the <i>Privacy Act</i>, you have the right to access your personal information and to request corrections if you believe that your personal information is inaccurate or incomplete. ## C – Consent

I, the undersigned, hereby give my consent to the Controlled Goods Program and the designated official of the above-mentioned registered business to use the security clearance that I obtained from the above-mentioned government and any information relative to such clearance.

I, the undersigned, have read the privacy notice above and consent to the collection, use, or disclosure of my personal information in this application for its subsequent verification, inquiry, assessment, and/or use in an investigation to determine the risk posed for the unauthorized transfer of items identified in the Controlled Goods List contained in the Schedule to the *Defence Production Act*.

My consent will remain valid until I no longer have the requirement to examine, possess, or transfer items identified in the Controlled Goods List contained in the Schedule to the *Defence Production Act*, until I am no longer associated with the business listed in the initial application, or until I send written notice to the Controlled Goods Program to revoke my consent.

**I understand that if I refuse to provide consent I will be prohibited from submitting this application and from examining, possessing, or transferring items identified in the Controlled Goods List contained in the Schedule to the *Defence Production Act*.**

### Law enforcement record check

**I consent that my personal information (including fingerprints when applicable) may be disclosed to Canadian or foreign law enforcement agencies or police forces, or other entities within or outside government departments and agencies (e.g. credit bureau) which conduct verifications and/or investigations, and that my personal information may be verified to enable an assessment of my trustworthiness and reliability for the purpose of security assessment and that the result of such verifications and/or investigations may be released to the Government of Canada or the Royal Canadian Mounted Police (RCMP) along with any other information about me or my associations contained in any accessible records and databases under their control.**

I further authorize any and all Canadian law enforcement agency – such as any Canadian or foreign police force, - or any person or organization, whether public, parapublic private or governmental to check, and release to the Controlled Goods Program or the RCMP, all of my criminal history, charges, court orders and any other information concerning me contained in any accessible records and databases under their control. I understand that this consent also authorizes any Canadian law enforcement agency – or any person or organization, whether public, parapublic private or governmental to release to the Controlled Goods Program or the RCMP any information enabling investigation of my associates and thus enabling determination of whether I am of good character.

For this same purpose, I give the RCMP permission to release to Controlled Goods Program, in whole or in part, the information it has collected during my security assessment and understand it may be released to the Designated Official of the registered person in relation to this security assessment.
